2019-2020 CALGARY PARATOUGH CUP presented by Petro-Canada “Free Gas for a Year” OFFICIAL CONTEST RULES AND REGULATIONS

WHO CAN ENTER: The 2019-2020 Calgary ParaTough Cup presented by Petro-Canada Free Gas for a Year contest (the “Contest”) is open to all legal residents of Canada, who have achieved the age of majority in their province or territory of residence on or before February 20, 2020, is a participant of the 2019-2020 Calgary ParaTough Cup, and who has raised at least \$1,000 in support of the Paralympic Foundation of Canada through the ParaTough Cup online fundraising platform, excluding employees of the Paralympic Foundation of Canada, Canadian Paralympic Committee (the “Contest Administrators”) and Petro-Canada (the “Prize Provider”) and affiliated organizations and each of their respective directors, officers, employees, agents, representatives, advertising or promotional agencies (including their directors, officers, employees) and persons with whom any of the foregoing are domiciled.

CONTEST PERIOD: The Contest starts on Tuesday, September 24, at 9:00 am Eastern Time (“ET”) and closes Thursday, February 20, 2020 at 1:00 pm Mountain Time (MT), unless suspended or cancelled earlier as set out herein (the “Contest Period”).

HOW TO ENTER: To be entered into the Contest, a participant of the 2019-2020 Calgary ParaTough Cup who raises \$1,000 in support of the Paralympic Foundation of Canada through the ParaTough Cup online fundraising platform will receive one (1) ballot for the Contest. For each subsequent \$100 that is raised by the participant in the same online manner, the participant will receive an additional ballot for the contest. (For example, raising \$1,025 would result in one (1) ballot into the Contest, while raising \$1,325 would result in three (3) ballots into the Contest.)

RANDOM DRAW / WINNER NOTIFICATION: One (1) entry will be selected in a random draw from among all eligible entry ballots. The draw will take place on February 20, 2020 at approximately 5:00 pm MT at the 2019-2020 Calgary ParaTough Cup venue (Repsol Centre). The selected entrant will be notified in person at the time of the draw. If the selected entrant is not present at the time of the draw, they will be notified by email, at the email address set out on their event registration. If a selected entrant has not responded by email within three (3) business days following the notice, incorrectly answers the skill-testing question, declines the prize, or fails to return the declaration and release specified below, another entrant will be selected until the prize is awarded. In order to be declared a winner, a selected entrant must first correctly answer (unaided) a time limited mathematical skill-testing question to be administered by telephone at a mutually agreed time and may be required to sign and return, within a stipulated period of time, the Contest Administrators’ form of declaration of compliance with the Official Contest Rules and Regulations, release of liability and publicity release. The Contest Administrators reserve the right to require proof of age and jurisdiction of residence prior to awarding the prize. The Contest Administrators will not be responsible for any failed attempts to reach a selected entrant. The odds of winning the draw are dependent upon the number of eligible entries received.

PRIZE: There is a single prize consisting of a one-time credit of \$2,704 in the form of Petro-Canada Gift Cards. The prize is valued at approximately \$2,704 CDN. The prize must be accepted as awarded, without
